1. Any physical activity can be dangerous. Activities require strenuous exercise and various degrees of skill. I understand that these activities can result In Injury to the person or child. I assume any and all risk and damage or injury while on Lake States Dairy center's Mooville, Interactive Area and/or Ropes course.
2. I am aware of the risk, hazards and danger of personal injury as a result of participation at Lake States Dairy Center, Inc., Fair Oaks Farms LLC and all affiliated entities.
3. I have read the set of rules and directions displayed on the signs in Mooville, the Interactive Area and/or the Ropes Course which I agree to follow and utilize at all times during operation and use of the units. I understand that it is my responsibility to ensure that my children understand the rules. Failure to explicitly follow the rules will lead to Immediate expulsion from Lake States Dairy Center, Inc. I certify that I and/or my child are in good health and that I and/or my child have no physical limitations which would preclude safe participation in Mooville, the Interactive Area and/or the Ropes Course at Lake States Dairy Center, Inc.

In consideration for the admission of my child, I hereby release, waive and forever discharge and covenant not to sue Lake States Dairy Center, Inc., Fair Oaks Farms LLC, any affiliated entities, owners, agents, employees, officers, directors, trustees and all other persons or entities acting on its behalf, from any and all claims, actions, damages, liability, cost or expense Including attorneys fees which are related to or arise out of or in any way connected to my child's participation at lake States Dairy center, Inc and/or Fair Oaks Farms LLC.

By execution of this agreement, It is my intention to assume all risk of Injury and do hereby surrender and waive any rights to sue or exercise any legal right to seek damages against Lake States Dairy Center, Inc., Fair Oaks Farms LLC, all affiliated entities, owners, agents, employees, officers, directors, and/or all other persons or entitles acting on its behalf.
6. I acknowledge that my or my child's participation in Mooville, the Interactive Area and/or the Ropes Course is strictly voluntary. I hereby certify that I am over 18 years of age; I have carefully read the foregoing covenant not to sue and acknowledge that I understand and agree to all of the above terms and conditions. Prior to signing this agreement, I have had an opportunity to ask any and all questions. I am aware that by signing this agreement, I assume all risks and waive and release all substantial rights that I may have and possess.
